Products should be stored at room temperature, away from direct sunlight and excessive heat, above 40°C.

Products should not be used after their expiry date.

Manufacturing and packaging are carefully controlled and inspected, using procedures specified by a Formal Quality System, which conforms to the requirements of EN ISO 9001:2008.
